The SLSA cannot pay you any compensation, nor can they order a Land Surveyor to pay you compensation to settle your complaint. Monetary claims must be pursued through the Courts.

(Please note that the SLSA cannot ordinarily intervene in fee disputes between Land Surveyors and their clients and cannot order a Land Surveyor to issue a refund or other compensation.)
